1. IDENTIFICATION

Do you have any identification documents or documents with your name on it?

Do you receive Centrelink or are you eligible?

Do you have a bank account or a medicare card?

Were you born in WA? If no, where were you born?

Do you need identification? What for?

2. DEBT

Is anyone chasing you for money?

Do you have any payments due or unpaid accounts? Eg: car loan, rent

Do you have any issues with superannuation, ?

Do you have any bank accounts, vehicles, or other assets/savings?

3. FINES

Have you received any Court fines?

Have you received any infringements/tickets?

Are you currently paying off a debt to the Fines Enforcement registry? If so, how?

How would you like to deal with your outstanding fines?

4. CRIME

Have you had any contact with the police recently? For example, have you been questioned, arrested, given a move on notice?

Are you due in Court? If so, when and what for?

Have you missed any Court dates? If so, when and what for?

Are you aware of any outstanding warrants in your name?

Are you on any Court orders?

5. CIC

Have you been the victim of a crime? If so, when and did you report it to the police?

Have you experienced domestic violence? If so, when was the last incident?

Did you require any medical attention from the incident?

Was the perpetrator charged with anything?

Have you received any paperwork from CIC requesting you pay any money?

6. DRIVER'S LICENCE ISSUES

Do you have issues with your driver's licence?

Has it been suspended for driving related offences (not unpaid fines)? If so, for how long?

7. VIOLENCE RESTRAINING ORDER

Do you need to take out a VRO or FVRO?

Has someone taken a VRO or FVRO out against you?

When did you get it? Have you objected to it?

8. HOUSING

Are you currently on the Department of Communities wait turn or priority housing waitlist?

Have you been told you won't be placed on the list?
